The Food and Beverage Establishment Grant provides grants up to \$30,000 to restaurants, bars, coffee shops, and other food and drinking businesses affected by the COVID-19 pandemic. 1. What is a private foundation, or family foundation? Technically, it is a not-for-profit entity that can be controlled by a person, family or business. Sometimes private foundations are referred to as 'family foundations'. They are organized exclusively for charitable, educational, religious, scientific and literary purposes under Section 501(c)(3) of the IRS Code.
