If a family had no income, their tax credit would be 100% of the poverty line (\$20,780 for a family of three). If the family's earned income increased to half the poverty line (\$10,390), their tax credit would decrease to \$15,585. In fiscal year 2018, the TCJA required us to incur a transition tax on deferred foreign income not previously subject to U.S. income tax at a rate of 15.5% for foreign cash and certain other net current assets, and 8% on the remaining income. The TCJA reduced the U.S. federal statutory tax rate from 35% to 21% effective January 1, 2018.
